SCHEDULE OF AMENDMENT  
TO  
BY-LAWS  
OF  
BRIARWICK HOMEOWNERS ASSOCIATION, INC.

Article IV, Section 1, of the By-Laws is amended to read as follows:

Section 1. Number. The affairs of the Association shall be managed by a Board of at least three (3) but no more than five (5) directors, who need not be members of the Association. The number of directors may be fixed from time to time by a majority vote of the members present, in person or by proxy, at a duly called meeting of members, at which a quorum is present.
