ORGANIZATIONAL MEETING

Meeting was called to order at 7:12 PM with all Directors present.

Treasurer's Report: Andy Sinkiewicz

2017 Proposed Budget: Following discussion:

Motion made by Lynda to approve the 2017 Proposed Budget (copy attached) as presented and based on the Annual Assessment of \$435, second by Jeff.

Motion carried unanimously.

Investment of three (3) Certificates of Deposit: The Association currently has three Certificates of Deposit; one (1) \$25,000 at BB & T and two (2) \$8,874.69 and \$5,410.79 at Bank of the Ozarks (formerly C1 Bank). Also, a Money Market Account at Union Bank in the amount of \$25,277.52. (Amounts stated are as of current financial statement.)

Following discussion of reinvesting the three (3) CD's and funds from the Money Market Account, Board agreed to leave \$10,000 in the Money Market account and reinvest the three (3) CD's and difference from Money Market account into one CD with the bank offering the highest rate of return (currently Bank of the Ozarks at 1.15%).

General Board Discussion to Include New Business:

Motor Bikes – Underage children and teens are riding motor bike on the roadway. Board discussed establishing a policy. Sue will send copy of a policy that was established by another association.

Paving – Approximately thirteen (13) years ago the roads were resurfaced at a cost of \$39,289. Sue was asked to get comparison bids.

Road Depression – An area of depression in the road, near Patti's house (3182 Edgemoor Drive) has been noticed. Sue will have Pinellas County Roads Department it looked at.

Future Board Meeting Dates to be January, March, May, July, September, August and October: — Lynda will check with the Fire House for dates and Sue will check with the Lutheran Church of the Resurrection. Board will be notified when dates/places are booked.

Unfinished Business: No Unfinished Business at this time.

New Business:

Sidewalks and Curbs – Sue will ask CurbKing to look at the sidewalks and curbs for any areas that need repair/replacement.
