Stan will review the scope of work with Dol-Fan Construction to be sure each trip hazard and broken sidewalk is included in the project.

- A. Annual Members meeting and Election of Directors is scheduled for October 27. Stan suggested that the Board of Directors be increased to 5 members. This issue will be discussed at the Annual meeting.
- B. Cindy is directed to contact The Master Assn. to have the entry trees trimmed up, have the noisy gate repaired and to ask that annual flowers be added to Briarwick entry as is done at other entrances in the community.
