#### I. Call to Order

Meeting called to order by Wolever at 7:01 pm. A quorum of the board was attained.

#### II. 2014 Budget

Motion by Wolever to amend proposed budget. Proposed budget amended to increase legal by \$1000, decrease landscape by \$1000, decrease irrigation repairs by \$800 and increase reserves by \$800. Proposed Budget further amended to increase annual dues by \$5.00 to \$425, with the additional \$320 funds raised going to Reserves. Seconded by Haberer. Wolever, Haberer, Kelly, Lueck in favor. Barbosa opposed. Motion carried 4-1.

Motion by Haberer to approved 2014 Proposed Budged as amended. Seconded by Wolever. All in favor. Motion carried. 2014 Budget approved with assessment at \$425 / lot / year.

Motion by Haberer to ratify approval of Landscape request by 3924 Belmoor. Seconded by Lueck. All in favor – motion carried.

e. **Collections:** Haberer reported that one of the delinquent accounts has been settled, including the attorney cost deposit for the lien filing.

Motion by Haberer to refer the remaining delinquent property (line 4 on the AR list) to the attorney for collections. Seconded by Lueck. All in favor. Motion carried.
